- 4) Presentations:
  - a) Chris Bonshor - GSA Club
    - i) Requesting \$2800 for crafts, displays, event hosting, field trip, supplies, guest speakers
    - ii) Field trips are skating & bowling
    - iii) Event hosting includes Glow Up! (dance), Pride at GWG, movie night
      - (1) Note: schools take turns hosting the Glow Up! dance, so the hosting school finances the event
      - (2) There is also other funding for the dance
    - iv) There will be multiple guest speakers
  - b) Stephen Wilhite - Performing Arts
    - i) Requesting funds to take theatre students to see Anastasia at Gallery 7, and to bring "Caged" to GWG (which would be open to all students, not just theatre students)
    - ii) Going to watch productions allows students to see final product, instead of just practicing all the time
  - c) Calvin Patterson - RC Club
    - i) Requesting \$1075.20 for 8 RC cars (approx \$120 each), and \$727.98 for a 9' x 12' RC track
    - ii) Dane Gehman (EA) has been bringing his own RC cars which are being heavily used
    - iii) Planning to run an RC intramural league

- d) Jenny Cho - E-sports
  - i) First year of E-sports had 18 students, this year we have 40 students
  - ii) Need additional equipment
  - iii) Asking for funding for equipment, trophies, and coaching
    - (1) Coaching would be for 20-30 students, and would run all three seasons in 2025/26
- e) Michael Florizone - Film Festival (presentation was a pre-recorded video, not in person)
  - i) Requesting funds for awards & lanyards, as well as new red carpet (which was worn out)
  - ii) The PAC learned that the red carpet had been loaned out to other schools for various events (Chuck will remind Mr. Florizone that items purchased by the PAC are to be used by GWG only)
